Notice of Posting of Extraordinary Losses

MTI Ltd. (hereinafter the "Company") announces that it will recognize extraordinary losses in the financial statements for the fourth quarter (July 1, 2018 - September 30, 2018) of the fiscal year ended September 30, 2018. An outline of the extraordinary losses is as follows.

1. Posting of extraordinary losses

Mainly due to the following matters, extraordinary losses of 815 million yen on a consolidated basis and 1,252 million yen on a non-consolidated basis will be posted.

(i) Posting of valuation loss on shares of affiliates on a non-consolidated basis

With respect to shares of Clinical Platform, Inc. and Video Market Corporation, which are consolidated subsidiaries of the Company, the Company will recognize valuation loss on shares of affiliates of 1,223 million yen, by taking into account the business environment, future outlook, etc.

(ii) Posting of amortization of goodwill on a consolidated basis

As a result of recognizing valuation loss on shares of Clinical Platform, Inc. as described in (i) above, the entire goodwill regarding said company, amounting to 730 million yen, will be posted as amortization of goodwill in the consolidated financial statement.
